What is the Rutgers University Senate?

- It is the principal shared-governance advisory body to the President.
- It is the sole institution that represents the entire community of faculty, students, staff, administrators, and alumni to the President of Rutgers and to the Board of Governors.
- It exercises legislative authority on certain matters delegated to it by the Board of Governors.



Who are the Senators?

- The total entitlements for Senators vary from year-to-year depending on numbers of students and faculty.
- Entitlements for part-time lecturers, alumni, and staff are consistent year-toyear.
- Typically, the number of voting Senators is approximately 200.



How is the Senate managed?

- The Executive Committee meets prior to each Senate meeting.
- Its primary duties involve:
 - discussion and issuance of charges to committees to investigate and report on matters brought before it
 - receipt of the committee reports
 - docketing of reports and other matters for review by the whole Senate
 - set the agenda for forthcoming Senate meetings
- The Executive Committee may act on behalf of the Senate, if necessary, between full Senate meetings.



Senate Meetings

- The Senate meets monthly, 8 times each academic year during the fall and spring semesters.
- The schedule is available at: <u>senate.rutgers.edu/meetings</u>.
- Senators should schedule their availability from 10:00 am to approximately 4:00 pm for Senate business.
- The daily schedule for Senate meeting days includes:
 - 10:00-11:50 am: Senate committees
 - Noon-1:00 pm: Faculty, student, staff, and alumni caucuses
 - 1:10 pm to ~4 pm: full Senate meeting

- Matters for possible consideration by the Senate should be submitted via the Senate website (https://senate.rutgers.edu/university-senate-charge-proposal)
- What is required:
 - a brief statement of the proposed charge
 - a short rationale describing the issue with relevant background information
 - what committee you anticipate would consider the charge
