(v) How do policies about professional development opportunities differ among schools and Chancellor-led units?"

The motion to refer this item to the Faculty and Personnel Affairs Committee was adopted.

The second was a motion to adopt a <u>Resolution on the President's Role in Conducting Contract</u> <u>Negotiations Fairly and Equitably</u>.

This resolution was adopted.
