I am an extraordinarily researchactive faculty member at a Research I institution, and CourseAtlas negatively impacts my ability to do research. Full stop. When I am completely or partly "at the mercy" of CourseAtlas with few or no options to modify my schedule via use of program-specific spaces, I am always given a three or more day a week teaching schedule which, added to a fourth day of meeting time means I simply do not have the substantial blocks of continuous time I need for my research. Every semester I have a different schedule and that utter lack of predictability also makes all other facets of my life more difficult. (I don't have family care responsibilities at the moment but know that CourseAtlas is a nightmare for many colleagues who do.) It also hinders my ability to program in class preparation/grading time in an efficient manner, particularly in the semesters when I teach graduate seminars and need especially intensive blocks of prep time immediately beforehand (before CourseAtlas I never had problems with this, but I now have to settle for terrible schedules those semesters just to get in the class prep time I need). Course Atlas has also damaged the interdisciplinary academic program I work in because it schedules courses originating in different departments against each other. That then results in low enrollments for some courses (which can also impact whether or not they are allowed to be offered in future) and makes it more difficult for some students to complete their requirements in a timely manner, or limits their options to do so.

Return to the prior system, which worked better for all concerned. I have NOT seen any persuasive evidence that CourseAtlas has had a massively positive impact on students, one that would counterbalance all of the negative impacts I have seen personally and for many colleagues. Wouldn't that information be shared if that were the case? If CourseAtlas is maintained then the number of hours faculty are expected to indicate for their availability each semester should be greatly reduced *so that we can actually regain some control over our time.* The percentage of our work time we are expected to devote to all facets of teaching (not just time in the classroom) in a Research I institution is 40%. Yet we are required to indicate far more hours per week availability. Perhaps less blunt, more sophisticated algorithms would make that possible.

On a personal level, my husband is also a faculty member and before CourseAtlas we were able to always teach on the same days, which was a real boon with commuting (we have only one car). Now this is impossible. Sometimes it works and sometimes it doesn't. As a department chair (who is not responsible for scheduling directly but who has great knowledge of it), CourseAtlas has been terrible for enrollments. My department does not have a highly structured curriculum; few classes have prerequisites. This makes it impossible for us to use the features like course combinations. The result is that we often have classes in the same fields scheduled by Course Atlas at the same time. One semester, 30% of the department's classes were scheduled in the same timeslot. This is bad for students and bad for us.

Other faculty will I imagine voice their anger and disappointment. I just want to raise one point about this software. It has hollowed out the exact things that a department should be able to cultivate, especially in the humanities, since we cannot build a culture associated with the spaces in which we hold classes. This might not apply to students whose interaction with Rutgers is primarily in the studio or lab. But for those who are getting humanities majors, they should have spaces where they take classes, run into faculty and graduate students, and are generally surrounded by the culture. That cannot happen when our classes are routinely scheduled elsewhere. This is my third job; I have also had positions at UCLA and Michigan, and this is the first school where I have seen this kind of casual disregard for departmental culture. There are many reasons to think that this algorithm is designed around the wrong values, but this has been one of the costs that I find maddening. Let me just add that classrooms in my building are often empty at the exact same time that I am running a seminar ten to fifteen minutes away. I realize that I'm not a part-time worker; in fact, I'm going to be the person in charge of "interfacing" with CourseAtlas/InfoSilem next year. At RBS-NB&Nwk, we, as faculty, are not asked our preferences for Course Atlas. Instead we have the same multisection courses and assign them to classrooms in the RBS Building 100 Rock. When we are at capacity in a time slot, we do get rooms outside of 100 Rock. As far as the RBS faculty are concerned, we still work as we did before Course Atlas. The other comment is that we should just go back to the old system with 20 minutes between classes, with the same time slots on all campuses. Students are not allowed to schedule classes consecutively on different campuses in New Brunswick with the possible exception of between Livingston and Busch. That still is problematic if one has to take a bus with 30 minutes between classes. However, if it is really important to be on time, get a bike. You can get from Busch and Livingston by bike very quickly, well within 20 minutes, and the same between Busch and College Ave and Livingston and College Ave. And this is the case for someone who is 3-4 times as old as any of the traditional undergraduates and in any weather in which the school is open and with the old fashion bike with a battery for power. And with the current system, the buses should not be crowded in the short period between classes. Priority should be given to the few students who must get to another campus. Others can wait, or get a bicycle.

Get rid of Course Atlas. To preserve larger rooms without Course Atlas, reassign rooms that would have held the number that finally registered for a course in the corresponding previous year and slot that the class was offered.

CourseAtlas has been a disaster for students, faculty, and Rutgers as whole. As faculty have been telling administrators at all levels since CourseAtlas was called Infosilem, the system does significant harm to education and research at Rutgers. Imposing CourseAtlas scheduling has discarded decades of departments' and programs' knowledge and experience in balancing student and faculty needs, while increasing the logistical burden on program directors and their staff in repairing problems created by the system, with NO **EVIDENCE WHATSOEVER of** benefits to anyone. My students continue to stumble in late to class complaining of long bus rides between campuses. My department, English, one of SAS's largest, has frequently had few and in some cases no classes in our home building. The English Writing Program has been able to function only by negotiating an exemption from CourseAtlas for our 100-section 355:101 College Writing course. Meanwhile faculty and especially undergraduate program staff are intensely demoralized by the unpredictable outputs of the system and the perennial threat that a new semester will deliver an unlivable schedule. In 2019, the NB School of Arts Sciences faculty unanimously passed a resolution calling for an indefinite pause to what was then called Infosilem, on the basis of its demonstrated record of poor performance at other universities and its disastrous "simulation" rounds at Rutgers. The then-Executive Dean ignored our resolution, but our criticisms then have been proven entirely justified. The time has come to restore faculty oversight to scheduling and to stop foisting CourseAtlas on students and faculty. It solves none of the very real organizational problems at Rutgers, and its costs go beyond its (considerable) dollar price in damage to faculty and staff morale. As for students, they are already inured to the "RU Screw" but they are not the

less harmed by further degradations.

CourseAtlas routinely schedules my courses at times that conflict with longstanding research commitments and make it impossible to maintain a steady research schedule from semester to semester. I also cannot block off time for all administrative commitments (regular monthly department meeting, monthly undergrad directors meeting, etc.) because this many blockoffs would make it impossible to arrive at a workable schedule. I am routinely assigned to classrooms that are too small or too large for the number of students in my classes, many in deteriorating condition in the river dorms. I was much happier with the scheduling and teaching conditions under the old system, and I did not hear as many reports from students of being shut out of classes they needed for a major/minor/language sequence by scheduling conflicts or rules. The only thing that makes community possible is local authority. The turn to CourseAtlas is part of the university's complete commitment to eliminating local authority over anything. Why did the different starting times for classes on the different campuses come to an abrupt end? Because CouaseAltas couldn't handle the different. Consequence? Riding the busses now is an experience that is universally reviled and hated, because we've returned to the selfinduced, self-selected traffic iam model of class changes. No one who had any genuine interest in the quality of undergraduate education would let this system stand for a semester longer, but at Rutgers the response is, as always, "Nothing can be done about it." Infuriating and one of many reasons I am retiring early.

... I've had mixed results with a semester of teaching across 5 days at 8am and at 7:30pm, which is unrealistic when we have a long commute and young children who need a lot of caregiving and rides to school in the morning and again after school.

The Period 1-4 stretch is too long in my opinion to be all in one category of work time. For example, if we teach at 8:30am and then again at 2-3:20pm, we have obstacles to overcome with managing childcare and driving the children to school at the same time as morning teaching and then the problem is there again at the afternoon class. And there's all the empty time in between where we are just idle.

Here are some compelling reasons I had to share with SAS to get my schedule adjusted from teaching 4 days back to back thanks to CourseAtlas that I think should be considered in the ways that it is affecting research, pedagogy and our students: sacrifice the quality of my teaching and pedagogical practices. This schedule does not allow for enough time in between teaching days to prepare strong pedagogies to support student learning towards the course objectives, one of these courses fulfilling the writing core for SAS. Writing courses require more pedagogical and strategic planning to achieve the course goals. Furthermore, having a day or two in between teaching days will also allow me to grade things on time to best support my students' progress meanwhile sustaining a 4-hour roundtrip commute between Brooklyn and New Brunswick, NJ. Teaching 4 days a week would require me to sacrifice the quality and time dedicated to my research, my attempt to balance research and teaching, and infringe in achieving tenure. I would be doing this meanwhile handling a commute totaling 16 hours per week. Teaching 4 days a week will be counter-intuitive to supporting me as a tenure-track faculty member whose goal is to achieve tenure at this institution. Although I did select those days as being available, it does not mean I am available. I selected the days I can teach, but we are not allowed to select the maximum amount of days per week we'd prefer to teach. The inability to differentiate between those two things is lacking for this scheduling system. In other words, we select options of availability to the UOE scheduling system, but somewhere there are no options for choosing or stating that we prefer 2

teaching days per week.

Every department is capable of determining on their own, what teaching schedule optimizes signups/attendance for our students. When we used to make these schedules, we were aware of a wide range of factors (acquired over many years of lived experience), including things like somewhat similar course offerings in other departments, which CourseAtlas (InfoSilem) has no way of knowing. Every department, including ours, also understood well what the needs of the faculty were, in terms of teaching times, and could figure out without CourseAtlas how to balance those priorities vs the priorities of the programs. Ironically, since the implementation of CourseAtlas, we are still basically trying to generate schedules that we would have generated in the past anyway. It's just that now it requires extra administrative effort to jerry-rig the CourseAtlas scheduling algorithm and to secure rooms that are off CourseAltas's grid. This is a highly irritating, time-consuming task that does not improve education in the slightest, but does. I am sure, result in additional administrative bloat, which has been plaguing American universities for the past few decades.

At best, CourseAtlas can be a useful tool for departments to consult when making our schedules. It *can* provide useful information about room availability and possible overclumping of course offerings at certain times. We can also get this information directly from our students, but CA is probably better positioned to gather it. CA *should not* have the power of actually scheduling our courses. And like I said above, in actually it really doesn't have that power. We just find workarounds to get back to what we actually need. Stop wasting our time and start trusting people on the ground, who are in classrooms day in, day out, to make the necessary decisions. We do it anyway. You just make it more annoying.

I am incredibly frustrated because I am spending over \$40,000 per year (seriously) for five days per week, yet somehow for three semesters in a row CourseAtlas is forcing me to teach early morning or late evening at times when I do not have childcare (daycare hours are 7: 30 - 5:30pm, I have a 40 minute commute). I have had to switch to online teaching one semester and I even had to swap classes with another instructor for the Fall 2025 because the scheduling team has not been willing to accommodate my childcare schedule. One administrator told me to "consider Care.com" to help with childcare expenses. One of the things I value most about my job is the flexibility of my schedule. I feel like CourseAtlas has taken this away from me. I am currently looking for jobs in the private sector so my hours are set during times I actually have childcare. I am really frustrated by CourseAtlas. It has taken away some of the joys of teaching for me.

As an older professor, I have devoted a great deal of time to making my last years at RU ones where I contribute to undergraduate teaching and to helping students think critically about the multiple challenges they will face in the world which is clearly in crisis. That requires that I can teach in places and at times that it is best to reach first- and second-year students before they have moved, in most cases, to a major in the STEM fields. Course Atlas has not completely blocked that. I can requesty classes on Livingston campus through our department AA (a campus where few others from my department teach) and usually get times that work, but what course Atlas does badly is then give me a reasonable schedule. Too many back-to-back classes and too many classes at times that I know do not appeal to students. Plus too many times when Course Atlas has scheduled my colleagues to teac as well (which has kept me from asking many of them to appear for a particular class with me -- an aspect of my teaching that I value and which has helped our undergraduates. On a more general level, I have been struck in our department discussions by how many of my younger colleagues have life situation scheduling to do that course atlas makes diffiuclt or impossible--and makes me worry that they will bolt Rutgers for a more teaching friendly university.

 Overall, the system is promising as a way to equitably distribute rooms. However, due to the many real-life constraints, the process is still quite manual and in some ways inefficient. Information transfer between departments and the (very helpful!) scheduling staff requires a lot of messages, human intervention, and tuning that CA is in principle meant to reduce. Fundamentally, I think it could be made to work as intended, if departments were given sufficient flexibility to better express constraints on times/rooms/etc. (i.e., additional parameters accessible in database fields, rather than text comments).	Two major pain points with CA are: (1) the lack of sufficient bulk editing tools for large multi-section courses with multiple deliveries, e.g., editing the times of all section lecture components, without editing recitation/lab times. (The ability to do some kind of scripting and automation would be great.) (2) Much of the scheduling information is currently communicated through comments in text boxes that a scheduling officer has to read and implement. This adds a lot of effort and makes it difficult to check the consistency of the schedule at submission time since the CA timetables and room information are nearly useless during the input process. So, for example, if we are in a position where we are requesting specific times, rooms, and/or other parameters, ideally we should have access to do that using the system itself.
