RUTGERS UNIVERSITY SENATE EXECUTIVE COMMITTEE MINUTES November 7, 2025

The regular meeting of the University Senate Executive Committee (EC) was held on Friday, November 7, 2025, from 9:00-11:00 a.m. remotely via Zoom. The time change was due to President Tate's inauguration occurring in the afternoon, at which the Chair would be officiating and several EC members attending.

Chair's Report – Lucille Foster, Senate Chair

Chair Foster called the November 7, 2025, Senate EC meeting to order at 9:02 a. m. A Chair's report was not presented given the time constraints of the meeting thereby enabling as many agenda items as possible to be considered.

Secretary's Report – Morgan Smith, Senate Administrative Assistant

RBHS Chancellor Committee Search Senate Representation

Senator Rob Scott drew the committee's attention to the recommendations listed in charge S-1909-1 Searches for University Leadership. While the recommendations are not adopted by the University, Senator Scott held that the process outlined should be strictly followed. However, the EC determined that its nominees should be drawn from among current Senators and not the University at large. The EC identified three representatives, namely, Senators Geza Kiss, Wendy Purcell, and Robert Schwartz. Chair Foster concluded that the Executive Secretary shall survey EC members on whether these nominees will be presented for endorsement at the December Senate meeting, or presented and accept other nominations invited from the floor to be voted on in order to put forth three Senators in total.

Executive Committee Newark Student Representative

Senator Paul Boxer volunteered to reach out to the Newark student Senators. A call out will be sent on Monday by the Executive Secretary to Newark student Senators.

Senate Social and Merchandise

Chair Foster reviewed the results of the survey and will follow up with the AllColors representative to get a meeting with the EC to discuss Senate branded items.

Listserv Communications – Senator Ashleie Gordy

Senator Ashleie Gordy left the meeting before this agenda item, submitted by her. It will be moved to Old Business for the December EC meeting.

Academic Freedom Group Update

Chair Foster summarized the November 4,2025 meeting held between the EC, AAUP, and faculty council chairs. Senator Anna Haley reported that the New Brunswick Chancellor Francine Conway is working on convening a point person for those faculty experiencing attacks on academic freedom.

Discussion- Chancellor Brian Strom, RBHS

Ad Hoc Committee to Investigate Current Trends and Issues Regarding Federal Landscape Changes Impacting University Operations requests updates:

- Name change to Rutgers MADC Taskforce
- Updated charge language: This ad hoc committee/taskforce was established in April 2025 in response to the Senate MADC Resolution approved on March 28, 2025. Its purpose is to advance the principles of *mutual academic defense* for Rutgers University – including collaborative and coordinated protection of Rutgers' and other higher education institutions' academic freedom, institutional integrity, and the research enterprise amid a changing federal and state landscape. The taskforce continues that work by engaging Rutgers leadership, including the University President, Board of Governors, and senior administrators, to explore the principles and practices consistent with mutual academic defense aligned with Rutgers' core values and strategic interests. The committee also collaborates with shared governance leaders at other New Jersey colleges and universities to build a statewide higher education coalition (NJ-MADC) that strengthens collective defense of academic freedom and representative governance; the Senate approved a resolution joining this body on October 17, 2025. In addition, it supports internal communication and educational efforts within Rutgers to deepen understanding of mutual academic defense principles and the University's role in advancing them.

Because the MADC Taskforce ad hoc committee needed editorial changes to the name and members on the website, the EC agreed the changes could be made without formal vote. The updated charge language will be on the agenda for vote during the December EC meeting.

Due to time constraints of the meeting, the remaining agenda items will be moved to the
